

F.E. WARREN HUNTER MANAGEMENT AREA

Open **August 15, 2023 thru December 31, 2023** for the take of **Antelope** in hunt area **38** during specific seasons as published in the 2023 Game and Fish Commission Regulations

GENERAL RULES:

- Each hunter must possess a valid permission slip while in the field
- Each hunter must display a valid vehicle pass in the window
- Hunting by foot only
- Leave gates as you find them
- Non-hunting, non-permitted persons may accompany a permitted hunter with a valid permission slip and do not possess a firearm
- No camping and campfires
- GPS/Mapping Service is highly recommended when accessing this property
- **No littering**—carry out everything you bring in

RESTRICTIONS

- No take of ANY OTHER SPECIES (including predators) or any other activities (including collecting antlers) without landowner permission
- Preseason scouting is not allowed
- Access within closed areas (see map) is not allowed
- Driving on closed roads or behind closed area gates is not allowed
- Use or construction of blinds or tree stands are prohibited
- Any commercial activity, including outfitting or guiding is not allowed
- Do not shoot in the direction of livestock, roads, windmills, stock tanks or buildings
- Do not damage range improvements or harass livestock
- No travel through HMA for the take of wildlife not listed on permission slip
- All hunters and companions must visibly wear **400 square inches of fluorescent orange clothing** while in the field
- Use of ground stakes (including decoys) or digging is prohibited unless a Base Dig Permit (Building 322) is obtained
- Blinds may not be placed within 150 yards of another stand or blind

F.E. Warren HMA SPECIFIC RULES:

- Military or Department of Defense ID or personal sponsorship with a valid base security is required.
- Base Hunting Permit (\$5) must be purchased and a Hunter Orientation and Liability Release Form must be completed before hunting (Building 151).
- All hunting access is prohibited during Force Protection Conditions Charlie or Delta.
- The use and possession of crossbows or firearms prohibited.
- Access only during dates specified on permission slip for current year.
- Drive on **established** roads only.
- **Possession or use of ORVs, as defined in WY Statute 31-1-101(K), is prohibited.**
- Bring Identification, relevant antelope and archery license, and HMA permission slip.
- Viscera and inedible animal parts may be double bagged and discarded in the carcass dumpster. Animal organs may be left at kill site if an area of low visibility.

AFTER HARVEST

- Hunters must report all killed or wounded pronghorn. Harvests may be recorded within 24 hours via phone or in person. Wounded animals should be reported immediately to (307)-773-3501 or (307)-773-5098.

- CWD samples: Hunters are reminded the Department is collecting CWD samples from deer and elk.

DEFINITIONS:

- TAKE:** Means hunt, pursue, catch, capture, shoot, fish, seine, trap, kill, or posses, or attempt to hunt, pursue, catch, capture, shoot, fish, seine, trap, kill or possess.
- Established road:** means any road or trail that has been graded or constructed to carry motor vehicles or on which repeated motor vehicle traffic has created well defined tracks.
- Designated road:** means only established roads that are marked with a white arrow sign as open to motor vehicles. Roads not marked with a white arrow sign are **closed** to motor vehicles.
- Wet or muddy road:** all roads are closed when conditions are wet or muddy.
