

Wyoming Sage-Grouse Local Working Group Project Proposal Form

PROJECT APPLICATION CRITERIA (please read before completing/submitting application):

1. All project proposals need to be submitted on the Wyoming Game and Fish Commission's Sage-Grouse Local Working Group Project Proposal Form. Projects must be reviewed and approved by the affected Local Sage-Grouse Working Group(s) (LWG).
2. Project funding shall be awarded for the purpose of implementing projects that address primary threats to sage-grouse as identified in local Sage-Grouse Conservation Plans. Applicants should read the appropriate plans and tailor projects and project proposals accordingly.
3. Projects will be evaluated based on consistency with Wyoming's Core Area management strategy, local Sage-Grouse Conservation Plan(s), likelihood of success, project readiness, matching funds, multiple species benefits, significance at local/state/regional level, duration of benefits, and adequacy of monitoring.
4. Award funds are distributed as reimbursable grants, meaning the grantee (the entity awarded the funds) must submit for reimbursement of expenses incurred as a result of the project. "Up front" funding is not allowed. For-profit entities are not eligible for grants but may be contracted by grantees to conduct project actions approved by the LWG and outlined in the grant agreement. Grant agreements shall be initiated, maintained, and amended if necessary by the Wyoming Game and Fish Department (Department). Project activities for which the grantee will seek reimbursement may not begin until the effective date of the grant. Grants shall expire annually on September 30th and may be renewed at the Department's discretion.
5. Overhead/administrative costs may not exceed ten percent (10%) of the overall project funds requested.
6. Purchase of capital equipment (items over \$500) is not allowed. Short-term lease of such equipment is acceptable.
7. For habitat improvement projects, including water developments, details of the post-treatment livestock grazing management plan must be included in the project description. Habitat treatment projects must also be consistent with the *Wyoming Game and Fish Department Protocols for Treating Sagebrush* (July 2019).
8. Research projects, including all projects that involve radio telemetry, should be conducted with the rigor and intent to publish in peer-reviewed scientific press. The grantee shall

be responsible for ensuring all applicable permits are obtained (i.e. Chapter 33 permit issued by the Department).

9. Habitat projects conducted on private lands should be partnered with programmatic sage- grouse efforts, such as a U.S. Fish & Wildlife Service Candidate Conservation Agreement with Assurances (CCAA), NRCS Sage-Grouse Initiative (SGI) or other landscape scale, sage-grouse specific efforts.
10. Project proponents must comply with all applicable federal guidance and regulations related to the Build America, Buy America Act, Publ. L. No. 117-58, §§ 70901-52. All iron, steel, manufactured products, articles, materials, and supplies that are incorporated into or affixed to a permanent or semi-permanent fixture on the landscape must be produced in the United States. A product, article, material, or supply is produced in the United States if it was manufactured in the United States and the cost of the components of the manufactured product that are mined, produced, or manufactured in the United States is greater than fifty-five percent (55%) of the total cost of all components of the manufactured product, unless another standard for determining the minimum amount of domestic content of the manufactured product has been established under applicable law or regulation.
11. Annual progress reports, a final report, and a fiscal close-out report are required for each project.

13. Maps should be reduced in size and pasted at the end of the application, not submitted as separate attachments.
14. The completed application total file size should not exceed 2.5mb and be submitted in Word or PDF format only.
