

- 496 resident hunters responded to this survey (surveyed from Carbon and Natrona Counties)
-

- 232 of 473 (49%) respondents indicated their preference for keeping Areas 66 & 70 general
 - 241 of 473 (51%) respondents indicated their preference for changing Areas 66 & 70 to a limited quota (LQ) season structure
 - 23 respondents did not indicate a preference
-

- 301 (64%) respondents applied for a limited quota license in the last 5 years, 172 (36%) did not
 - Of the 301 that applied for a LQ license in the last 5 years, 126 (42%) preferred general and 175 (58%) preferred LQ
 - Of the 172 that did not apply for a LQ license in the last 5 years, 106 (62%) preferred general and 66 (38%) preferred LQ

- 256 (54%) respondents indicated they had hunted in Area 66 and/or 70 in the last 5 years, 213 (45%) did not; 4 (1%) did not provide an answer to this question
 - Of the 256 that had hunted in Area 66 and/or 70 in the last 5 years, 141 (55%) preferred general and 115 (45%) preferred LQ
 - Of the 213 that did not hunt Area 66 and/or 70 in the last 5 years, 88 (41%) preferred general and 125 (59%) preferred LQ

- 115 (24%) respondents indicated they had harvested a mule deer in Area 66 and/or 70 in the last 5 years, 358 (76%) did not
 - Of the 115 that harvested a mule deer in Area 66 and/or 70 in the last 5 years, 68 (59%) preferred general and 47 (41%) preferred LQ
 - Of the 358 that did not harvest a mule deer in Area 66 and/or 70 in the last 5 years, 164 (46%) preferred general and 194 (54%) preferred LQ

- 133 of 496 (27%) respondents typically hunt 1 area in years when they held a general license
 - 149 of 496 (30%) respondents typically hunt 2 areas in years when they held a general license
 - 105 of 496 (21%) respondents typically hunt 3 areas in years when they held a general license
 - 53 of 496 (11%) respondents typically hunt 4 areas in years when they held a general license
 - 19 of 496 (4%) respondents typically hunt 5 areas in years when they held a general license
 - 4 of 496 (1%) respondents typically hunt 6 areas in years when they held a general license
 - 2 of 496 (<1%) respondents typically hunt 7 areas in years when they held a general license
 - 31 of 496 (6%) respondents did not answer this question

- 72 of 496 (15%) respondents felt hunter densities in Area 66/70 were very unacceptable
 - 89 of 496 (18%) respondents felt hunter densities in Area 66/70 were somewhat unacceptable
 - 202 of 496 (41%) respondents were neutral regarding hunter densities in Area 66/70
 - 59 of 496 (12%) respondents felt hunter densities in Area 66/70 were somewhat acceptable
 - 31 of 496 (6%) respondents felt hunter densities in Area 66/70 were very acceptable
 - 43 of 496 (9%) respondents felt hunter densities in Area 66/70 were did not provide an answer
