

# Mule deer hunter attitude survey



# Introduction

- Survey of resident mule deer hunters to learn about opinions, attitudes, and values related to mule deer hunting and management
- Survey allowed hunters a chance provide feedback on a variety of topics related to mule deer management in Wyoming
- Results will be utilized to inform stakeholders and mule deer managers about resident opinions on mule deer hunting and management in the state of Wyoming



# What is the purpose of the attitude survey?

- Game and Fish is managing a public resource
- Management decisions are rooted in how the public wants their resource and recreation managed – not only biology
- This survey was last conducted in 2017, 2012, 2006
- The attitude survey is different from the annual harvest survey





# **Attitude survey methods**







The survey is conducted by Wyoming Survey and Analysis Center (WYSAC) at University of Wyoming The survey questionnaire was coordinated with Game and Fish The survey was conducted in August and September of 2023



# 2023 Mule deer hunter attitude survey methods

77,762	10,183	7,487	8,303	8,988
Survey was sent to 77,762 resident hunters who purchased or applied for a deer license in the previous 3 years	10,183 responses were received (11.8%), removed	7,487 responses received were valid (9.7% of surveys sent)	A postcard with a link was sent to hunters without an email on file. 10.7% of the valid responses were not associated with an email	Surveys were sent electronically via email. 8,988 valid responses were completed by using the link in the individual email invite. 1,195 responses were completed online via passcodes provided on the postcards and email.



# **Comparison to previous surveys**

# Past surveys

- Data collected by phone
- Sampled the population
- Extensive follow-up to minimize non-response bias
- Less survey bias
- Phone surveys are more expensive
- Conducted by a private contractor

# 2023 survey

- Electronically surveyed
- Sent to all individuals who bought or applied for a license in previous three years (2020-22)
- 2-3 follow-up emails were sent to encourage nonrespondents to respond
- Conducted by WYSAC

# Respondents were given a choice of 5 levels

- Extremely satisfied
- Satisfied
- Neutral
- Dissatisfied
- Extremely dissatisfied

Respondents were asked about their satisfaction with several mule deer management topics

**2023 Mule deer hunter attitude survey** Questions pertaining to hunter satisfaction



How satisfied or dissatisfied were you with the overall quality of your mule deer hunting experience the last time you hunted in Wyoming?







65% of those surveyed in 2023 reported the quality of their mule deer hunting experience has declined over the last three years

2012	74%	
2017	79%	
2023	40%	





The decrease in the proportion of satisfied hunters coincides with a larger decline in mule deer abundance statewide.

## To what extent did you feel crowded by other hunters while hunting mule deer in Wyoming over the past three years?





#### 2017 Survey

- 53,000 active hunters statewide
- 26% of dissatisfied hunters selected crowding

2023 Survey

41,000 active hunters
46% selected crowding

#### -23.5%

Change in active hunters from 2016 to 2022





#### Key takeaways More deer = higher hunter satisfaction

- Far fewer hunters are satisfied with their hunting experience than in previous surveys
- Declines in hunter satisfaction mirror declining mule deer populations
- Other factors such as crowding are probably far less impactful than mule deer abundance

#### How much do you support or oppose separate licenses for mule deer and white-tailed deer?





How satisfied are you with the current approach by Game and Fish for managing hunting opportunities, using a combination of general and limited quota hunt areas?





#### Do you prefer general license seasons or limited quota seasons?





#### How important is it to you, personally, to hunt mule deer in Wyoming every year?

85% Moderately and very important





How much would you support or oppose limiting the number of resident hunters in the field to reduce crowding in Wyoming, even if it makes it less likely that you would draw a license?





## How acceptable or unacceptable would limited quota seasons in all hunt areas in Wyoming be to you?





Currently resident general license holders can hunt in any general hunt area statewide. Would you support or oppose requiring resident general license holders to select a single region of the state to hunt?





How much would you support or oppose mandatory harvest reporting, meaning every license holder is required to complete a harvest survey (regardless of whether they harvested an animal)?





How much do you support seasons designed to reduce CWD levels through harvesting deer at greater rates to reduce density?

> **3X** Support vs. oppose





Should the Department consider a weapon of choice season, meaning mule deer hunters would be restricted to a specific weapon type and season structure (bow only or rifle only)?





#### Key takeaways Maintain opportunity

- Respondents generally support the current framework combining general licenses in some areas with limited quota licenses in others
- Strong opposition to any changes that would limit opportunity, even if they would reduce crowding
- Strong support for mandatory harvest reporting and addressing CWD
