Fifty Percent (50%) Resident Disabled Veteran Application for Fishing License (Proof of residency required)

Wyoming State Statute § 23-2-201 (f): Any resident disabled veteran who receives **fifty percent (50%) or more service connected disability compensation from the United States Department of Veterans Affairs** may apply to the department for a resident disabled veteran's lifetime fishing license. The license entitles the resident disabled veteran to take any fish within Wyoming at the time, in a place, in a manner and in an amount as provided by law and the orders of the Commission. Valid documentation (official Department of Veterans Affairs or official Armed Forces logo must be present in the document's letterhead) must be attached to this application to be considered complete.

One Hundred Percent (100%) Resident Disabled Veteran Application for Game Bird, Fish and Small Game License (Proof of residency required)

Wyoming State Statute § 23-1-705 (d): The department shall issue without charge lifetime game bird, small game and fish licenses to any disabled veteran who is **one hundred percent (100%) disabled as determined by the United States Department of Veterans Affairs**. The license is valid so long as the licensee remains a Wyoming resident. Wyoming Game and Fish Commission Regulation, Chapter 44, Regulation for Issuance of Licenses, Permits, Stamps, Tags, Preference Points, and Coupons, Section 14(d): **One hundred percent (100%) disabled does not refer to disability compensation**. Valid documentation (official Department of Veterans Affairs or official Armed Forces logo must be present in the document's letterhead) must be attached to this application to be considered complete.

Disabled Hunter Permit

Wyoming Game and Fish Commission Regulation, Chapter 35, Section 5 (f): Applicant can produce to the Department a decision letter, issued within the immediately preceding five (5) years from the date of application, by the United States Department of Veterans Affairs or any branch of the Armed Forces of the United States showing the person to have a **service connected disability of at least seventy (70%) percent** (official Department of Veterans Affairs or official Armed Forces logo must be present in the document's letterhead).

Hunting Season Extension Permit

Wyoming Game and Fish Commission Regulation, Chapter 35, Section 10 (a)(ii): Any person may be issued a Hunting Season Extension Permit which allows a qualified applicant to hunt antelope, deer or elk five (5) days prior to the earliest opening regular season date in the hunt area(s) and for the sex of antelope, deer or elk set forth by limitations of their license as specified in Section 2 of the current regulation for that species (Commission Regulations Chapter 5, Antelope Hunting Seasons, Chapter 6, Deer Hunting Seasons; Chapter 7, Elk Hunting Seasons), provided the person requesting the hunting season extension permit: Can produce a decision letter issued by the United States Department of Veterans Affairs, or any branch of the armed forces of the United States, showing the person to have a **one hundred (100%) percent service connected disability** (official Department of Veterans Affairs or official Armed Forces logo must be present in the document's letterhead).

Licenses and permits are issued only at Wyoming Game and Fish Department Regional Offices located in JACKSON, PINEDALE, CODY, SHERIDAN, GREEN RIVER, LARAMIE, LANDER, CASPER or the Wyoming Game and Fish Headquarters located in CHEYENNE.
