No person shall receive more than two (2) general raptor capture licenses **OR** one (1) general raptor capture license and one (1) limited quota raptor capture license in any calendar year. No person shall receive more than one (1) limited quota raptor capture license in any calendar year.

Applications for general raptor capture licenses for all raptor species will be accepted January 1 through December 31 for the calendar year in which the license is valid. Separate applications and fees shall be submitted for each raptor applied for. Applications for limited quota raptor capture licenses for peregrine falcons shall be submitted not later than March 1 during the calendar year in which the licensee intends to take a peregrine falcon. All applications shall be submitted to the License Sales and Accounting Section as indicated below.

The Department, on a drawing basis, may issue a maximum of five (5) limited quota raptor capture licenses to capture peregrine falcons annually. In the drawing, four (4) licenses shall be reserved for residents and one (1) license shall be reserved for a non-resident.
