Executive Summary

Each year the Wyoming Game and Fish Department (WGFD) requires mandatory registration of all harvested gray wolves and surveys gray wolf hunters to quantify harvest, hunter success, and hunter effort. This information helps the Game and Fish manage wolf populations and plan next year's hunting seasons. Harvest and hunting activity summarized in this report correspond only to gray wolves designated as Trophy Game Animals and does not include gray wolves designated as Predatory Animals. The harvest statistics presented in this report were based on data collected from registered gray wolf harvests and 622 responses to a voluntary harvest survey sent to 2,407 license holders and extrapolated to represent 2,470 gray wolf hunting licenses issued. A total of 34 gray wolves were harvested in Wyoming during the 2024-2025 hunting season.
