# **Watercraft Registration Application Instructions**

Please read the following instructions entirely before completing the Watercraft Registration Application form. Incomplete forms and/or missing documentation will result in your request being returned unprocessed.

If you have questions, please call (307) 777-4638.

For additional information, please review Wyoming Game and Fish Commission Regulation, Chapter 22, Watercraft Regulation.

### What watercraft must be registered?

All motorboats powered by propulsion machinery of any type and operated on the waters of this state shall be registered (to include electric trolling motors). No person shall, operate nor shall the owner permit the operation of any motorboat, unless the motorboat is numbered in accordance with state law, applicable federal law, or a federally approved numbering system of another state; the certificate of number issued for the motorboat is in full force and effect; and, the identifying number set forth in the certificate of number is displayed on each side of the bow of the motorboat.

## Proof of Ownership for New Registration and Transfer of Ownership

The following documentation is required for new registrations and transfer of ownership:

- Completed Watercraft Registration Application signed by the Watercraft owner as identified on the Certificate of Title
- Copy of Wyoming Certificate of Title with a valid Hull Identification Number (HIN) (must be in current applicant's name)
- Copy of proof that all sales or use tax have been paid
- Registration Fees

If your watercraft was purchased prior to January 1, 2010, please call (307) 777-4638 for additional information regarding the necessary proof of ownership documentation.

#### Watercraft Registered in Another State

A watercraft which has been registered or titled in another state can be registered in Wyoming with the following documentation:

- Completed Watercraft Registration Application signed by the Watercraft owner as identified on the Certificate of Title
- · Copy of Certificate of Title from another state (must be in current applicant's name)
- Current copy of state's watercraft registration or renewal notice (must be in current applicant's name)
- Registration Fees

#### **Watercraft Renewals**

Watercraft can be renewed for a period of one year or three years. You will receive a renewal notice by mail. Please verify all information on the renewal notice before submission. Make any corrections to the renewal notice if necessary. The following documentation is required to renew your watercraft registration:

- Renewal Notice or Completed Watercraft Registration Application signed by the Watercraft owner as identified on the Certificate of Title or as the owner in the WGFD watercraft system.
- Registration Fees

Please be advised, if you allow five or more years to pass without renewing your watercraft registration, the registration number assigned to your watercraft shall be recycled and may be issued to another watercraft. It is to your advantage to keep your registration current in order to maintain the same registration number. If your registration has lapsed for longer than five years, the following documentation is required to renew your watercraft:

- Completed Watercraft Registration Application signed by the Watercraft owner as identified on the Certificate of Title or as the owner in the WGFD watercraft system.
- Evidence of prior registration to include renewal notices or registration documentation. (must be in current applicant's name)
- Registration Fees

If you don't have the documentation required, please call (307) 777-4638 for additional information regarding the necessary proof of ownership documentation.

### **Dealer Registrations**

Those businesses who sell or demonstrate watercraft in the state of Wyoming may request Dealer Registration Numbers. The following documentation is required:

- Completed Watercraft Registration Application signed by the Watercraft owner
- Properly completed Streamline Sales and Use Tax Agreement—Certificate of Exemption Form
- \$30.00 Registration Fee

The Cheyenne Headquarters Office or any Wyoming Game and Fish Regional Office (Casper, Cody, Green River, Lander, Laramie, Jackson, Pinedale, and Sheridan) can process watercraft transactions. Dealer Registrations must be processed in Cheyenne. If mailing to Cheyenne, please allow ten (10) business days for processing.
