

The Lone Tree Creek Hunter Management Area 2016

The **Lone Tree Creek Hunter Management Area** is open for managed **antelope, deer, elk, and cottontail rabbit** hunting during the specific species seasons as published in the current Wyoming Game & Fish Commission Regulations and in accordance with the following limitations:

- **Each hunter** must have a **permission slip** and a **vehicle pass** to the specific hunter management area and species they are hunting. **Anyone without Department permission shall be subject to trespass charges.**
 - Non-hunting/non-permitted persons may assist in game retrieval on the HMA as long as they are accompanying a permitted hunter and do not possess a firearm.
 - Apply for limited permission slips online July 11 – August 1st. Results will be available August 3rd.
- **Antelope** Hunting Access (Hunt **Area 37**):
 - **Archery**—Unlimited number of permission slips available for August 15 – September 19.
 - **Regular Season**—Forty (40) permission slips issued for September 20 – 28.
 - **Regular Season**—Forty (40) permission slips for September 29 – October 14.
- **Deer** Hunting Access (Hunt **Area 61**): (ARCHERY HUNTING ONLY)
 - **Archery**—Unlimited number of permission slips available for September 1 – 19.
- **Elk** Hunting Access (Hunt **Area 6**):
 - Ten (10) permission slips issued for elk hunting October 1 – December 14.
 - Ten (10) permission slips issued for antlerless elk hunting December 15 – January 31.
- **Cottontail Rabbit** Hunting Access:
 - Unlimited number of permission slips available for October 15 – March 1.
- **Persons may not scout or trespass** outside of their designated access period!
- **The only entrance to the Lone Tree Creek HMA is on the west end of the HMA along the Harriman Road, two miles south of I-80 (Exit 342).**
 - **In order to enter the HMA, EACH hunter must bring their signed permission slip to the city office (2101 O'Neil Avenue, Room 210) between 8 am and 5 pm Monday – Friday to receive the combination for the (green) padlock.**
 - **Vandalizing or otherwise tampering with the padlocks, fences, and signs is strictly prohibited.**
- Motorized travel is allowed on **established roads ONLY**. Abide by all signs and posted areas.
 - All Off-Road Vehicles (ORVs) are PROHIBITED. *ORVs are defined by Wyoming Statute §31-1-101(K).*
 - **No foot or vehicular travel on or across railroad right of ways.**
 - **Close all gates** behind you.
- Do not shoot in the direction of livestock, buildings, roads, windmills, stock tanks, or any object other than the animal you are hunting. Do not damage fences, range improvements, or harass livestock. Livestock has the right of way.
- **Hunting is by foot or horseback only.**
 - **Horses must stay out of pastures which have livestock present.**
- Portable blinds for hunting may be used and may remain in the field for up to 72 hours as long as the hunter's **name and current address are clearly printed on the exterior**. The hunter is responsible for any damage done to portable blinds left in the field.
- No overnight camping or campfires are allowed. Do not litter.
- **Report any wildlife violations by calling 1-877-WGFD-TIP (1-877-943-3847)**. Future hunting opportunities depend on hunter compliance with all ranch rules as well as G&F laws and regs.

The Lone Tree Creek Hunter Management Area 2016

The Hunter Management Program, as part of the Wyoming Game and Fish Department's Access Yes Program, manages hunters on large sections of private lands and, by doing so, preserves hunting opportunities for Wyoming hunters. A Hunter Management Area (HMA) may refer solely to private lands or a combination of private, state trust, and federal lands within ranch boundaries.

The Lone Tree Creek Hunter Management Area is located west of Cheyenne and south of Exit 342 on I-80 on properties belonging to the City of Cheyenne. This property provides a home for livestock and a large diversity of wildlife such as deer, antelope, elk, waterfowl and rabbits, as well as many nongame species.

Hunters must obtain written permission prior to hunting on the HMA. **Each** hunter must have a complete permission slip with them and each vehicle must have a vehicle identification slip visible on the dash, windshield, or mirror. As part of the HMA agreements, each access area has a unique set of ranch rules, created cooperatively with the landowners. It is the hunters' responsibility to know, understand and comply with all Ranch Rules and Game and Fish Commission Regulations. Failure to comply may result in fines and/or the termination of access privileges.

Hunters: Don't let the illegal riders and gate-busters degrade big game habitat and steal our hunting opportunities.


