Open NOVEMBER 21st, 2024—December 31st, 2024 for the take of ANTLERLESS/FIVE POINTS OR LESS ON EITHER ANTLER ELK during specific seasons as published in the 2024 Game and Fish Commission Regulations

GENERAL RULES:

- Each hunter must possess a valid permission slip while in the field
- Each hunter must display a valid vehicle pass in the window
- Drive only on established roads
- Foot or horseback access is allowed
- Use certified weed free hay for your horses while on the ranches
- Leave gates as you find them
- Non-hunting, non-permitted persons may accompany a permitted hunter with a valid permission slip
- Be careful with campfires remove all fire rings
- GPS/Mapping Service is highly recommended to access this property

RESTRICTIONS

- No take of ANY OTHER SPECIES (including predators) or any other activities (including collecting antlers) without landowner written permission
- Preseason scouting is not allowed
- Access within closed areas (see map) is not allowed
- Driving on closed roads or behind closed area gates is not allowed
- Blinds or tree stands are not allowed. Temporary portable blinds may be used, but must be removed each night
- Any commercial activity, including outfitting or guiding is not allowed
- Do not shoot in the direction of, or within 100 yards of, livestock or buildings
- Do not damage range improvements or harass livestock
- Do not leave camps set up the entire season
- No travel through HMA to take wildlife not listed on permission slip

Deer Creek HMA specific rules:

- Deer Creek HMA is open for antlerless and five points or less on either antler elk hunting only.
- Five point or less on either antler elk may only be taken on area 7 Type 2 licenses.
- No motor vehicle use on Stearns Limited Partnership property.
- No ORV/ATV use on True Ranches, LLC property.
- Duck Creek Flats is a private road. Hunters must have a permission slip for the Deer Creek HMA to use this road and may not access it until November 21st.
- Do not travel on roads when they are excessively wet or muddy.

DEFINITIONS:

- <u>Take</u>: means hunt, pursue, catch, capture, shoot, fish, seine, trap, kill, or possess, or attempt to hunt, pursue, catch, capture, shoot, fish, seine, trap, kill or possess.
- Established road: means any road or trail that has been graded or constructed to carry motor vehicles or on which repeated motor vehicle traffic has created well defined tracks.
- <u>Designated road:</u> means only established roads that are marked with a white arrow sign as open to motor vehicles. Roads not marked with a white arrow sign are **closed** to motor vehicles.
- Wet or muddy road: when road is wet and muddy
