LEWIS RANCH HUNTER MANAGEMENT AREA-

Open <u>November 1, 2024 thru January 31, 2025</u> for the take of Antlerless ELK in hunt area 8 during specific seasons as published in the 2024 Game and Fish Commission Regulations

GENERAL RULES:

- Each hunter must possess a valid permission slip while in the field.
- Each hunter must display a valid vehicle pass in the window.
- Foot or horseback access is allowed.
- Leave gates as you find them Non-hunting, non-permitted persons may accompany a permitted hunter with a valid permission slip and do not possess a firearm.
- No camping and no littering—carry out everything you bring in.
- GPS/Mapping Service is highly recommended when accessing this property.

RESTRICTIONS

- No taking of ANY OTHER SPECIES (including predators) or any other activities (including collecting antlers, rock climbing, etc..) without landowner written permission.
- Preseason scouting is not allowed.
- Access within closed areas (see map) is not allowed.
- Driving on closed roads or behind closed area gates is not allowed.
- Use or construction of Blinds or tree stands are prohibited.
- Any commercial activity, including outfitting or guiding is not allowed.
- Do not shoot in the direction of, or within 200 yards of, livestock, equipment or buildings.
- No travel through HMA for the take of wildlife not listed on permission slip.
- Camping on State Trust lands is not allowed.

LEWIS RANCH HMA SPECIFIC RULES:

- Access only during dates specified on permission slip for current year.
- Bull Mountain Road is Closed
- Hunters who possesses unused Area 8 Type 1 or 8 elk license(s), in addition to the one listed on their permission slip, may take antlerless elk on the HMA during their permitted time.
- Youth Hunters may hunt antlerless elk without a permission slip as long as they are with a person with a current Lewis Ranch HMA permission slip.
- Hunting is by foot travel only.
- Motorized travel is allowed on the <u>power line</u> road "for game retrieval only" after 10:00 **AM and for the purpose of retrieving harvested antlerless elk only**.

DEFINITIONS:

- <u>TAKE</u>: Means hunt, pursue, catch, capture, shoot, fish, seine, trap, kill, or posses, or attempt to hunt, pursue, catch, capture, shoot, fish, seine, trap, kill or possess.
- <u>Established road</u>: means any road or trail that has been graded or constructed to carry motor vehicles or on which repeated motor vehicle traffic has created well defined tracks
- <u>Designated road</u>: means only established roads that are marked with a white arrow sign as open to motor vehicles. Roads not marked with a white arrow sign are **closed** to motor vehicles.
- <u>Wet or muddy road</u>: all roads are closed when conditions are wet or muddy.
