### LOWER NOWOOD HUNTER MANAGEMENT AREA

Open OCTOBER 15, 2024—NOVEMBER 15, 2024 for take of DEER during specific seasons as published in the 2024 Game and Fish Commission Regulations

#### **GENERAL RULES:**

- Each hunter must possess a valid permission slip while in the field
- Each hunter must display a valid vehicle pass in the window
- Vehicles allowed on county roads or state highway only (see map)
- Park only in DESIGNATED parking areas (see map)
- Foot access is allowed
- Leave gates as you find them
- Non-hunting, non-permitted persons may accompany a permitted hunter with a valid permission slip
- GPS/Mapping Service is highly recommended to access this property

### **RESTRICTIONS**

- No take of ANY OTHER SPECIES or any other activities (including collecting antlers) without landowner written permission
- Preseason scouting is not allowed
- Driving on closed roads or behind closed area gates or signs is not allowed
- Blinds or tree stands (temporary portable blinds may be used, but must be removed each day).
- Any commercial activity, including outfitting or guiding is not allowed
- Do not shoot in the direction of, or within 200 yards of, livestock or buildings
- Do not damage range improvements or harass livestock
- Camping on State Trust lands is not allowed
- No travel through HMA to take wildlife not listed on permission slip

## Galloway properties specific rules:

- Access only during dates specified on permission slip for current year
- Some pastures or areas may be posted closed to taking wildlife for certain periods of time because of livestock presence
- No access around corrals, barns, or any buildings
- No fishing
- No campfires
- No archery hunting
- Walk in access ONLY stay out of CLOSED areas

### **DEFINITIONS:**

- <u>Take</u>: means hunt, pursue, catch, capture, shoot, fish, seine, trap, kill, or possess, or attempt to hunt, pursue, catch, capture, shoot, fish, seine, trap, kill or possess.
- <u>Established road</u>: means any road or trail that has been graded or constructed to carry motor vehicles or on which repeated motor vehicle traffic has created well defined tracks.
- <u>Designated road:</u> means only established roads that are marked with a white arrow sign as open to motor vehicles. Roads not marked with a white arrow sign are **closed** to motor vehicles.
