Open <u>SEPTEMBER 1, 2024—JANUARY 31, 2025</u> for the take of **ANTELOPE and ELK** during specific seasons as published in the 2024 Game and Fish Commission Regulations

#### **GENERAL RULES:**

- Each hunter must possess a valid permission slip while in the field
- Each hunter must display a valid vehicle pass in the window
- Drive only on established roads to parking areas and on designated open roads (see map)
- Foot or horseback access is allowed
- Use certified weed free hay for your horses while on the ranches
- Leave gates as you find them
- Non-hunting, non-permitted persons may accompany a permitted hunter with a valid permission slip
- GPS/Mapping Service is highly recommended to access this property

# **RESTRICTIONS**

- No taking of ANY OTHER SPECIES or any other activities (including collecting antlers) without landowner written permission
- Preseason scouting is not allowed
- Driving on closed roads or behind closed area gates or signs is not allowed
- Blinds or tree stands are not allowed. Temporary portable blinds may be used, but must be removed each night
- Any commercial activity, including outfitting or guiding is not allowed
- Do not shoot in the direction of, or within 100 yards of, livestock or buildings
- Do not damage range improvements or harass livestock
- Camping on State Trust lands or within boundaries of HMA is not allowed
- No travel through HMA to take wildlife not listed on permission slip

## **Muddy Mountain HMA specific rules:**

- No ATVs/ORVs permitted on Miles Land & Livestock, Garrett Ranch, and Five Bar T Ranch, including on trailers or in trucks, unless traveling on designated route.
  - DO NOT POSSESS AN ATV/ORV IN THIS AREA OF THE HMA UNLESS TRAVELING ON DESIGNATED ROUTE!
- All ATVs/ORVs must access U.S. Forest Service lands by using designated route (see map).
- No parking or camping along designated ATV road on Porter Family Trust property.
- Miles Land & Livestock and Five Bar T Ranch will be closed to vehicle access in pastures surrounding their cabins during archery season, this area will be open to foot or horseback use only.
- Do not travel on roads when they are excessively wet or muddy.

### **DEFINITIONS:**

- <u>Take</u>: means hunt, pursue, catch, capture, shoot, fish, seine, trap, kill, or possess, or attempt to hunt, pursue, catch, capture, shoot, fish, seine, trap, kill or possess.
- **Established road:** means any road or trail that has been graded or constructed to carry motor vehicles or on which repeated motor vehicle traffic has created well defined tracks.
- **Designated road:** means only established roads that are marked with a white arrow sign as open to motor vehicles. Roads not marked with a white arrow sign are **closed** to motor vehicles.
