## PK LANE HUNTER MANAGEMENT AREA-

Open <u>SEPTEMBER 1, 2024 thru December 31, 2024</u> for the take of ANTLERLESS ELK during specific seasons as published in the current Game and Fish Commission Regulations

## **GENERAL RULES:**

- Each hunter must possess a permission slip while in the field
- Each hunter must display a vehicle pass in the window
- Park in the Designated Parking Area on PK Lane- Sheridan County Road 52
- Do not shoot in the direction of, or within 100 yards of, livestock or buildings
- Horses can not be used for hunting, horses can be used for game retrieval
- Leave gates as you find them
- Abide by all signs and posted areas
- Non-hunting /non-permitted persons may assist in hunting/game retrieval as long as they are accompanying a permitted hunter and do not possess a firearm or archery equipment

## **NOT ALLOWED**

- No motorized vehicles allowed including E-bikes
- Do not pick up antlers or dead heads
- No preseason scouting
- No commercial activity, including outfitting or guiding
- Do not damage range improvements or harass livestock
- No dogs allowed
- No camping or open fires; day use only.

## **PK LANE HMA SPECIFIC RULES:**

- Elk Hunt Area 37 Type 9 license: Three permission slips issued first come first served for each three day block September 1-15.
- Elk Hunt Area 37 Type 6, 9 and General license (Archery Only): Three permission slips issued first come first served for each three day block September 15-30.
- Elk Hunt Area 37 Type 6 licenses: Three permission slips issued first come first served for each three day block October 1– November 5.
- Elk Hunt Area 37 Type 6 and General license: Three permission slips issued first come first served for each three day block November 6-15.
- Elk Hunt Area 37 Type 6: 200 permission slips issued first come first served, valid November 16-December 31.
- Hunters can hold a maximum of 3 permission slips for this HMA
