during specific seasons as published in the 2025 Game and Fish Commission Regulations

### **GENERAL RULES:**

- Each hunter must possess a valid permission slip while in the field
- Each hunter must display a valid vehicle pass in the window
- Vehicles allowed on DESIGNATED roads only (see map)
- Park only on DESIGNATED parking areas (see map
- Foot or horseback access is allowed
- Use certified weed free hay for your horses while on the ranches
- Leave gates as you find them
- May take predators/wolves (with license, during open season) while hunting for big game species. After filling big game license, no further access for predator/wolf taking
- Non-hunting, non-permitted persons may assist in game retrieval as long as they are accompanying a permitted hunter

### **RESTRICTIONS**

- No take of ANY OTHER SPECIES (including predators) or any other activities (including collecting antlers) without landowner permission
- Preseason scouting is not allowed
- Driving on closed roads or behind closed area gates is not allowed
- Blinds or tree stands (temporary portable blinds may be used, but must be removed each day) are not allowed
- Any commercial activity, including outfitting or guiding is not allowed
- Do not shoot in the direction of, or within 200 yards of, livestock or buildings
- Do not damage range improvements or harass livestock
- Camping on State Trust lands is not allowed
- No travel through HMA to take wildlife not listed on permission slip

# Pitchfork Ranch specific rules:

- No take of mule deer
- No ORV's
- No fishing

# LHR, LLC specific rules:

- Little Rose Creek parcel is closed to ALL ACCESS from October 7 - October 21
- No take of mule deer
- No fishing
- No ORV's

- Blood Samples: Hunters are reminded that the Department is conducting brucellosis testing on elk. Hunters need to collect a blood sample and submit it for testing.
- CWD Samples: Hunters are reminded the Department is collecting CWD samples from deer and elk.

### **DEFINITIONS:**

- <u>Take:</u> means hunt, pursue, catch, capture, shoot, fish, seine, trap, kill, or possess, or attempt to hunt, pursue, catch, capture, shoot, fish, seine, trap, kill or possess.
- <u>Established road</u>: means any road or trail that has been graded or constructed to carry motor vehicles or on which repeated motor vehicle traffic has created well defined tracks.
- **Designated road:** means only established roads that are marked with a white arrow sign as open to motor vehicles. Roads not marked with a white arrow sign are **closed** to motor vehicles.
- ORV: a recreational vehicle primarily designed for off-road use...(see W.S. 31-1-106 (K) (i,ii,iii) also known as ATV's, SideXSide, 4 wheeler, Quad, ETC.
