GENERAL RULES:

- Each hunter must possess a valid permission slip while in the field
- Each hunter must display a valid vehicle pass in the window
- Drive only on DESIGNATED roads (see map & definitions)
- Park only in DESIGNATED parking areas (see map)
- Some areas on the southeast side of the HMA are open to vehicles on all ESTAB-LISHED roads (see map & definitions)
- Foot or horseback access is allowed
- Leave gates as you find them
- Non-hunting, non-permitted persons may accompany a permitted hunter with a valid permission slip
- GPS/Mapping Service highly recommended in accessing this property
- Access only during dates specified on permission slip for current year

RESTRICTIONS

- No taking of ANY OTHER SPECIES or any other activities without landowner permission
- Driving on closed roads or behind closed area gates or signs is not allowed
- Any commercial activity, including outfitting or guiding is not allowed
- Do not shoot in the direction of, or within 200 yards of, livestock or buildings
- Do not damage range improvements or harass livestock
- Camping on State Trust lands or within boundaries of HMA is not allowed
- No fishing
- No travel through HMA to take wildlife not listed on permission slip

Chimney Butte HMA specific rules:

- The Silver Creek Ranch and Flying Fish Hook Ranch (see map) are closed to all access.
- The Eastfork Cattle Company also allows snowmobile use in Pocket Creek when deep snow is present
- Please do <u>NOT</u> leave entrails from harvested elk in pastures with cattle

- <u>Designated road:</u> means only established roads that are marked with a white arrow sign as open to motor vehicles. Roads not marked with a white arrow sign are **closed** to motor ve-
