COYOTE CREEK HUNTER MANAGEMENT AREA (HMA)

Open <u>August 15, 2023—January 31, 2024</u> for the taking of SAGE GROUSE, WATERFOWL, RABBITS, ANTELOPE, DEER, ELK, MOOSE & MT LION during specific seasons as published in the 2023 Game and Fish Commission Regulations

GENERAL RULES:

- Each hunter must possess a valid permission slip while in the field
- Each hunter must display a valid vehicle pass in the window
- Vehicles must park in DESIGNATED parking areas only (see map)
- Foot or horseback only access is allowed
- Leave gates as you find them
- Non-hunting, non-permitted persons may accompany a permitted hunter with a valid permission slip
- GPS/Mapping Service highly recommended in accessing this property
- Access only during dates specified on permission slip for current year

RESTRICTIONS

- No taking of ANY OTHER SPECIES (except predators) or any other activities without landowner permission
- Driving on closed roads or behind closed area gates or signs is not allowed
- Blinds or tree stands (temporary portable blinds may be used, but must be removed each day) are not allowed
- Any commercial activity, including outfitting or guiding is not allowed
- Do not shoot in the direction of, or within 200 yards of, livestock or buildings
- Do not damage range improvements or harass livestock
- Camping on State Trust lands or within boundaries of HMA is not allowed
- No travel through HMA to take wildlife not listed on permission slip

Coyote Creek HMA specific rules:

- Coyote Creek HMA is closed to deer hunting October 1-2.
- When conditions allow, over-snow vehicles may be used for harvested game retrieval only, ONLY if such travel does no damage to the rangeland resources.

• CWD Samples: Hunters are reminded the Department is collecting CWD samples from deer and elk.

DEFINITIONS:

- <u>Take:</u> means hunt, pursue, catch, capture, shoot, fish, seine, trap, kill, or possess, or attempt to hunt, pursue, catch, capture, shoot, fish, seine, trap, kill or possess.
- <u>Established road:</u> means any road or trail that has been graded or constructed to carry motor vehicles or on which repeated motor vehicle traffic has created well defined tracks.
- <u>Designated road:</u> means only established roads that are marked with a white arrow sign as open to motor vehicles. Roads not marked with a white arrow sign are **closed** to motor vehicles.
- Wet or muddy road: when road is wet and muddy.
